#### 1. APOLOGIES FOR ABSENCE -

#### 2. APPOINTMENT OF CHAIRMAN AND VICE CHAIRMAN;

The Provincial Grand Master, R.W. Bro. Richard Olliver, re-appointed V.W. Bro. Graham Seeman as Chairman and W. Bro. Raymond Head as Vice Chairman. Appreciation was shown by the attendees !!!

#### 3. MINUTES OF THE PREVIOUS A.G.M.:-

The Minutes of the 12th. Annual General meeting held at Sindlesham Court on Thursday, 14th. September, 2019, had been circulated to all Lodge Representatives and Secretaries. They were proposed as an accurate record by W. Bro. J. Palmer and seconded by W. Bro. R. Head. All were in agreement and they were duly approved.

#### 4. Matters Arising:-

A further £1000 had been given to the Blood Bike Group which covers the Province of Berkshire and an appreciative response had been received from Captain Irani, Chairman of SERV OBN (see Appendix 2).

#### 5. Treasurers Report:-

The Treasurer reported that the statement showed that £21,000 had been paid out and £13,000 had been paid in to the account. There were sufficient funds in the account to cover expected expenditure and possible support for Brethren.

That the report be accepted was proposed by V.W. Bro. Graham Seeman and seconded by W. Bro. Raymond Head, with thanks to the Treasurer for managing the accounts under difficult circumstances.

All were in agreement and they were duly approved. The Secretary reported that he would include the balances it the Annual Report to the Charity Commisioners.

#### 6. Election of Officers :-

- **6.3. Secretary** W. Bro. H. Ranscombe was proposed by V.W. Bro. Graham Seeman and seconded by W. Bro. Raymond Head;

All the appointments received approval by those present with grateful thanks for their past services.

#### 7. Dates of Committee Meetings for 2021:-

The following dates were proposed – January 27<sup>th.</sup>, May 12<sup>th.</sup>, November 12<sup>th.</sup> – most likely to be via Zoom virtual meetings if the current crisis continues.

#### 8. Any Other Business:-

### 8.1. Support for the Mark Benevolent Fund through donations to Festivals - East Lancashire, 2021 and Surrey, 2022:-

W. Bro. Raymond Head Proposed that the annual support should be increased to £1,100. This sum was seconded by the Treasurer. That this way of supporting the MBF in 2021 and 2022 was proposed by V.W. Bro. Graham Seeman and seconded by W. Bro. John Palmer. All those attending the meeting were in favour of this.

#### 8.2. Berkshire-wide Charities for 2020/21/22:-

The President and Chairman proposed that the Thames Valley Air Ambulance and the Thames Hospice should be considered for future support. The Secretary agreed to follow up on the needs of these charities and report back to BeMBA.

#### 8.3. Support to the Berkshire Craft Festival:-

The President proposed that £1,100 be donated annually to the Berkshire Craft Festival in its remaining years, in appreciation of the support they gave to our Mark Festival. This was seconded by the Chairman and unanimously agreed by all those present.

#### 8.4. Members Fund :-

W. Bro. Tim Sherwood enquired if there was a special fund for Members needs and asked about the aim of the fund, which often had more income that expenditure. The Chairman explained that BeMBA's prime aim was the need of BerksMark Brethren and all request for assistance were promptly considered by the Executive. If finances allowed, then support would be considered for small, local Charities, then one Province-wide charity each year, then support for the M.B.F.

Berks Mark Brethren would always have first call on the funds.
